

2015 REVENUE: \$2 BILLION +8.1%

Barry-Wehmiller Group, a global supplier of manufacturing technology and services for a wide range of industries, reported record revenue of \$2 billion, an 8 percent increase, driven by organic growth and acquisitions by the company and its portfolio companies.

Foreign acquisitions included Hema in France, a manufacturer of filling systems for complex liquid foods such as edible oils, canned meats, dressings and pate; Bielomatik in Germany, which manufactures paper processing product lines; and Winkler + Dunnebier in Germany, which provides integrated mail, folded tissue and hygiene solutions.

U.S. acquisitions included Alliance Machine Systems in Washington state, which provides automation for high-speed rotary die cutter lines, flat bed and specialty corrugated box making machines; and Eberl Claims Service in Colorado, an independent adjuster firm that assists with daily claims and catastrophe claims handling.

Also during 2015, the company named William Kuhn vice president of finance, Neal McConnellogue president of BW Papersystems, Pete Carlson president of BW Container Systems and William Fricks president of Barry-Wehmiller International.

Bob Chapman, chairman and CEO,

co-authored "Everybody Matters: The Extraordinary Power of Caring for Your People Like Family," which was published by Random House Penguin in October and made The Wall Street Journal best seller list. The company's related Leadership Institute has conducted classes for more than 40 educational institutions, government organizations and private and public companies.

Chapman, whose family owns the company, is bullish on 2016. "We anticipate our revenue improving 20 percent, from \$2 billion to \$2.4 billion," he said. "All our investments have offset the overall softness in global markets."

The company's growth is driven in large part by acquisitions. Already this year, its Synerlink subsidiary, a packaging equipment provider, acquired Dairy Pack to expand its range of solutions and services in the fresh dairy market and beyond.
